

How to Submit Your Application

Students who are enrolled in a college or university in the US or Canada may apply. Completed applications are accepted between September 1st and October 15th only. From the list below, determine the nearest local AACE section to you. Submit your application to the individual listed, **no later than October 15th**. If there is no local section in your area, you may still apply by selecting the nearest section. The only restriction is that students in Canada must submit their applications to a Canadian section, and students in the US must submit their applications to a US section.

Each section selects the top four candidates from the applications submitted, and forwards them to the AACE Education Board for final judging and determination of scholarship award amounts. Notifications of results of the judging are mailed in February, and monetary awards are sent out the following August.
